**Special Education Budget Presentation**

Action

- Liz Therrien and Wende Proulx presented the budget. The budget has not been formally passed.
- The 2014-15 numbers were reviewed with an overall decrease in funding of \$616,981. Full implementation of the new funding model takes place September 2017.
- The 2016-17 budget proposed is to stay status quo for all

areas that affect special education. Excess capacity is still a factor while more children are entering our schools with more complex needs.

- SEAC will revisit the budget priorities if necessary in September.
