Welcome/Introductions

2 Trustees were introduced, as well as a new group of parents and staff who were in attendance.

PIC overview and By-laws

SO Graves provided an overview of what PIC does for the board/school councils.

Our by-law says that PIC will be made up of the chairs of the school councils. So, if you're chair, you're a voting member. And we're allowed to have up to 3 community members. The Board can appoint from various school roles. We have 1 secondary and 1 elementary principal on this committee.

At the next meeting, we will speak to updating the by-law to get a designate for each meeting.

Election of Chair/co-chairs

Motion: That Meredith J be appointed PIC chair/co-chairs for the 2023/24 School year. Moved by Meaghan Mullen, and second by Katlan Schewmner. *Carried*

PRO link – review application, process and deadline.

SO Graves provided the info/formula for the PIC funds, to use for our own initiatives. On top of that, every school council gets \$500.



And then there's the PRO grant. PRO grant \$ has now been rolled into the GSN that the Board receives. We get \$1500 for the board, and then \$500 for each school. Details of the 2 options for administering these funds were reviewed. SO Graves wanted us to come to a consensus on how to distribute these funds, and we went around the committee for us to discuss. The overall consensus is that the application process is how we'd like to proceed.
