# Special Education Report - Kim Pauli

Our department has been providing some training to various employee groups across the board. On March 29<sup>th</sup> there will be a meeting for all Resource Teachers across the district. Presenters include Louise Maughan (Lead Psychologist) and Kara Macie (Lead Speech Pathologist), along with Learnstyle, who will train our DLRTs on Assistive Technology applications to improve their capacity to support students with their devices.

We are currently getting ready for the Spring staffing, and looking at school enrollment and other factors to determine where staff will be allocated for the 2023-24 school year.

Our May SEAC meeting will include a school visit. We will tour the Self-Contained classes at Chippewa on May 18<sup>th</sup>. We will tour from 11-12pm, meet for lunch at the Board Office shortly after 12pm, and then conduct our regular SEAC meeting beginning at 1pm. More information will follow in our next agenda.
