Welcome/Introductions

Membership Update – SO Graves

Everyone was approved at the recent board meeting for continuing their membership for this school year.

Presentation by Chris Walkling - EQAO Results 2022-23

- EQAO is moving forward with modernization of provincial testing with a number of efficiencies, both for students with and without IEPs. The process has been largely quantitative.
- The benefits of digitalization were reviewed, and it is an adaptive process.
- Reviewed 2018 current year with some details, although not typical.
- Reviewed the field testing that took place in 2021.



- Chris will be sharing the links that go along with the document with the SEAC group so that
 you can see more on the assessment, as well as the math formulas that Trustee Fuscaldo
 inquired about.
- 2021-22 results are providing us with a new "baseline"
- An increase in respect to 2018/2019 for OSSLT, and some improvements in grade 6 reading.
- Pleased with a strong participation rate, and about 26% had accommodation during this assessment (OSSLT).
- The difference of with and without IEPs on the OSSLT slide was reviewed/discussed.

Kara Macie – special guest– Right to Read – Summary

- Kara made a presentation on the Right to Read, and how all students deserve an equal
 opportunity to read. Kara shared some of the major recommendations of the Inquiry and some
 of the program interventions that are currently underway in our system.
- Oct 2019 OHRC Right to Read Inquiry was launched. The report was shared in February 2022. Our Board already had laid the groundwork to support the recommendations.
- The committee has requested that Kara returns for another meeting to continue with the presentation, as well as to provide an opportunity for our members to ask questions.
